



## Managing the Opioid Epidemic

### The Challenge

The opioid epidemic is costing lives and driving healthcare spending. In 2017, more than 191 million opioid prescriptions were dispensed in the U.S., and in 16% of U.S. counties, enough opioid prescriptions were dispensed for every person to have one.

Some startling facts about the opioid epidemic from the CDC include:

- In 2018, more than **72,000 Americans died from opioid overdoses**, a new record that equates to 200 a day.
- In 2017, the prescribing rate was **58.7 prescriptions per 100 people**, but some counties had rates that were seven times higher.
- Opioid use and overdose are on the rise; the **overdose rate increased 30%** from July 2016 through September 2017; however, that rate is **70% in the Midwestern region**.
- About **80%** of people who use heroin first misused prescription opioids.

The rising negative health consequences of prescription opioids also affect the costs of healthcare. On average, healthcare costs for people with opioid use disorder (OUD) are eight times higher than for people without OUD.

Training helps healthcare providers better understand, prevent and treat opioid use and misuse within the context of whole person health. In addition, better opioid management may have short- and long-term financial savings, even as Medicare and Medicaid appear to be developing reimbursement criteria around prescription and utilization.
